

# **The Jury of Conscience finding against the EU by Macedonian Manifest**

In the name of the Truth, Morality and Justice

The Moral Court – Macedonian Truth on the basis of the founding principles, aims and rules for the organising and functioning of the Court made up of Eftim Kletnikov as the President and Cvetan Gavrovski, Dardan Venetski, Sotir Kostov and Valeri Stefanovska. At their meeting on 13 May 2025, they viewed and assessed the behaviour and functioning of the European Union (EU) towards Macedonia and Macedonians in a longer period, as well as the detrimental impact of such actions, which are directly contra to the imperative norms of international law and ethical norms. The Court after a comprehensive debate and analysis of known facts, concluded that the conditions have been met to for the EU to be declared guilty on many basis, hence it delivered the following

## **MORAL JUDGEMENT**

Europe from the Macedonian people's songs has been described as a Babylonian Whorehouse guilty of implementing and support of genocide on the Macedonian people which has caused serious mental harm and collective trauma to the entire Macedonian people. The act was performed over a long time period. It all started in 1912/13 with the Balkan Wars. It is guilty because it openly supported the neighbours who during the Balkan Wars were partitioning Macedonia on the ground as well as forced assimilation of the Macedonian people. It is guilty because in Bucharest in 1913 together with the neighbours were partitioning Macedonia on the table and thus confirmed their genocide. It is guilty because after the Balkan Wars it supported the exile of hundreds of thousands of Macedonian from Aegean Macedonia, including the 28,000 refugee children who were torn from the arms from their mothers and dispersed across Europe in 1948. These Child Refugees are still banned from returning to their homes unless they declare themselves a Greeks by birth. This anti-civilisational act was ignored by Europe and no attempt was made to condemn this genocide. It is also guilty of throwing napalm bombs in 1948 over Macedonian towns and villages in occupied Aegean Macedonia. The EU is guilty because in 1992 it created and adopted the Lisbon Declaration which bans accession into the EU to a country bearing the name Macedonia. It is guilty because in 2001, together with its strategic partner the USA, supported the aggression of Macedonia by Albanian terrorist, from outside and internally. This lead to the imposition of the Ohrid Framework Agreement which redefined the Macedonian state. It is guilty, because in 2005, it imposed the Interim Agreement with Greece, in violation of Article 4 of the UN Charter. This condition forced Macedonia to negotiate with Greece about the naming of our own state the Republic of Macedonia.

The genocide continues today, in the most perverse way, with heated pressure, blackmail and threats for us to self-destruct our identity, so that we can't rise from the dead once

again. From us Macedonians they demand us to self-destruct and delete all that is Macedonian. They use the carrot and stick as a method. The carrot is entry into the EU, and the stick is the veto with which they threaten us if we don't accept all the genocidal demands of our neighbours. It is guilty because it openly supports the genocidal agreements with Bulgaria and Greece, and demands their strict implementation, even though they know very well that these agreements violate the imperative norms of international law, such as the Charter of the UN, the UN Declaration for Human Rights, the EU Convention on Human Rights, the Vienna Convention on Consular Rights and the Convention for the prevention and punishment of the crime of genocide. They are guilty, because they demand strict adherence to genocidal agreements with which us Macedonians are suspended from inalienable rights, such as Right to Self-Determination and Self-identification, as well as the suspension of State sovereignty. They have suspended our inalienable right to care for Macedonian minorities in neighbouring states. For us Macedonians they have suspended the universally accepted principles of International Relations and Diplomacy such as equality between nations between states and people, reciprocity and non-interference in the internal affairs of states. It is guilty because it supports the genocidal demands of the neighbours which demand from us Macedonians to give up on our own name, identity and language. It is guilty because it supports the demands to give up on our historical and cultural heritage, from our state symbols, but also to accept our neighbours to write our school text books. In one word, the EU is guilty supports genocide which is prohibited under international law. It is guilty because after the Referendum from 30/09/2018., where the Macedonian people clearly rejected the EU and NATO membership and rejected the Prespa Agreement. With this act, it practically imposed the ceasing of the accession process to prevent the possibility of blackmail and threats. The EU is the one that used its High Representative to solve the 'problem' in a Balkan Way. That meant nothing else but a recommendation for brutal violation of the Constitution and Laws of the Republic of Macedonia and even more brutal violation of the will of the people expressed at the mentioned Referendum, which shortly after transpired. Finally, the EU is guilty because prepared and adopted the Negotiation Framework, in which they built all the genocidal demands from our neighbours, as well as a Note from Bulgaria that they don't recognise the Macedonian language. With this act, the EU suspended its own Copenhagen Criterion for Entry into the Union. This all is implemented with a high degree of perversion, and this is the Veto and threats of destabilisation if we don't accept the genocidal demands.

In view of the above, the Moral Court has assessed that the EU is guilty of genocide which was and still is being implemented on the Macedonian people, because of which makes the **Utmost Moral Judgement of Guilt.**

## **EXPLANATION**

The Moral Court has no dilemma that Macedonia today is under huge pressure and all the anti-civilisational and genocidal demands from its neighbours and the EU, unprecedented in history of states and right to delete all that is Macedonian. For the Moral Court to pose a legitimate question whether our neighbours have the power and readiness to implement by themselves such a huge genocidal project not found in world history or are they supported by a lot more powerful, and the neighbours are simply executioners? The answer to this dilemma was given by the Macedonian people well over 100 years ago in a folk song **Europe the Babylonian Prostitute**. The Macedonian people is the one that directed its enemy, which allowed the most dirtiest of genocidal acts to be implemented by our neighbours. There are numerous sources of irrefutable evidence that show that the EU the driver of this genocidal project. It is it that prepared the latest Framework Agreement, which contain all the genocidal demands of our neighbours. The EU is the one that has not taken any step to force Bulgaria to implement the 16 legal rulings of the International Court of Justice initiated by Macedonians from Bulgaria. Instead of pressure over Bulgaria, the EU pressures Macedonia to accept genocidal demands.

Europe is the one that created the neighbouring states, Greece in 1832, Bulgaria and Serbia at the Berlin Congress in 1878 and Albania in 1913. At the Berlin Congress the foreshadowed Autonomy of Macedonia never came to life in practice. Europe is the one that does not support the re-establishment of the Macedonian state. The reasons are many, but the Court is not focused on them, rather with simply notorious facts that confirm the genocide, which are also numerous.

The genocide started with the Balkan Wars 1912/13, which was decades in the making. The period from the Berlin Congress to the Balkan Wars was used to prepare for the forthcoming planned genocide. Once it established the states in our neighbourhood, Europe is the one which supported the re-establishment of the Greek, Serbian and Bulgarian Churches, who were earlier under the Diocese of Ohridska Arch Diocese. Europe did not support the re-establishment of the Macedonian Orthodox Church, even though it was the First Church on the European continent established by Apostle Paul. Europe, was the one that supported the establishment of Greek, Bulgarian and Serbian Church councils with more that 2,800 Greek, Bulgarian and Serbian church schools, in which towards the end of the 19<sup>th</sup> century 156,000 Macedonian pupils were told they were Greek, Bulgarian or Serbian. Europe is the one that supported the Censuses of population during the Ottoman Empire based on a so called Milet system, that record Church membership as opposed to ethnic background. Because there was no Macedonia Church, the Census on the territory of ethnic Macedonia showed Greek, Bulgarian and Serbian believers but not Macedonian faith. This helped Europe to develop an excuse that Macedonia is geographic space inhabited by Greeks, Bulgarians and Serbs. With that the preparations for the forthcoming genocide were complete, Europe in 1912 gave our neighbours the permission to start with the physical genocide of Macedonia and Macedonians. At the Bucharest Congress in 1913 with their participation on the table Europe confirmed the partitioning of Macedonian land and the

assimilation of the Macedonians. Europe is the one that needs to be shamed with the genocide over the Macedonians. Hundreds of thousands of Macedonians were uprooted from their homes after that, including the 28,000 Refugee Children from Aegean Macedonia stolen from their mothers in 1948 and spread across Eastern Europe. Not one of these Macedonian Refugee Children have not been allowed to return to their home unless they declare to be Greek by birth. These people can not even realise not even inheritance law, and Europe is remaining silent about the genocide.

In 1944 after four years of revolutionary struggle the Macedonian state re-emerged in just one part. In order to prevent the unification of the Macedonians, Europe was the one that threw napalm bombs in 1948 over towns and villages in Aegean Macedonia.

From 1992 the EU changed its strategy and focused on identity genocide. Then through the Lisbon Declaration it was prohibited the country to become a member if it contained the name Macedonia. From that moment the Macedonians were practically told if they want to integrate into the EU they will have to self-erase its generic, divine, holy, biblical and inherited name Macedonia. This shameful genocidal decision has not been revoked to date.

In 2001, that same EU along with its strategic partner the USA, prepared and supported the logistic aggression on the Macedonian state by Albanian terrorists, for later to prepare and implement the Ohrid Framework Agreement which demolished the revolutionary foundations from ASNOM in 1944 and lead to the redefining if the Macedonian state.

In 2005, the EU along with its strategic partner prepared and imposed the Interim Agreement with Greece, which contravenes Article 4 of the UN Charter which details the conditions that must be met for states to be recognised at the UN. For us Macedonians, they added a new and extra condition. Article 4 of the UN Charter is an imperative norm in which no body can or is allowed to intervene. No one can or is authorised to take away or to add new conditions. This is backed by UN Court for Justice decision from 1948 which is mandatory for all future situations or cases. The international commission of 5 experts from Constitutional Law lead by Judge Badinter confirmed that the Republic of Macedonia met all four conditions for recognition, namely Article 4 of the UN Charter, but that was not enough for our enemies. With the Interim Agreement from 2005 they imposed a fifth extra condition and that is to negotiate with Greece over the name of our own state. They deliberately forgot the fact that Macedonia is not a new state. Macedonia as a member of Yugoslav federation is a sovereign state member of the UN from the moment the creation of the multilateral institution.

For Macedonia after the dissolution of Yugoslavia it would have been sufficient to note the transition from Socialist Republic of Macedonia to Republic of Macedonia. The Lisbon Declaration and the Interim Agreement prohibit this.

The genocide continues even today but in an even more perverted form, and that is identity self-liquidation. From us they demand to erase all that is Macedonian, so that we can't again

self resurrect. As methods of control they use carrots and sticks. The carrot is the EU and the brutal false promises for accession, and the stick is the Veto and the threats for destabilisation of the country if it does not accept the genocidal demands of the neighbours and the EU. The EU is the one that supports the genocidal agreements with Bulgaria and Greece and demands their strict implementation even though it knows all too well that they breach the imperative norms of international law, which makes these agreements unsustainable and able to be cancelled from the moment they were signed. Such agreements are treated as invalid with no legal power, because they suspend the highest and inalienable, such as the Right to Self-Determination and Self-identification. They suspended our state sovereignty and the inerasable right care for Macedonian minorities in neighbouring states. They have also suspended our universal principles of international diplomacy such as equality between states, non interference in domestic affairs and reciprocity. They don't apply to us. Sadly, the EU supports all this.

With the genocidal agreements they demand us to give up on our historical and cultural heritage and to accept for our neighbours to write our school text books. The Ancient history to the 7<sup>th</sup> century is placed in the Greek bag, and the middle ages up to 1944 are placed in the Bulgarian titles office. In this way, the Macedonians are forced to give up on their roots and historical continuity. Through this the EU want us to become a tree without a root, a fabrication of Tito, outsiders and thieves of the name Macedonia and Macedonians who on their way to the EU have to choose a new identity according to their wishes. If we reject this they threaten us with Veto and destabilisation.

For our luck, the only one who sanely observe this genocidal project is the Macedonian people who at the Referendum in 2018 said NO to EU and NATO and rejected the Prespa Agreement. According to the Constitution of the Republic of Macedonia the sovereignty rests with the people. Their decisions made at the Referendum can't be changed and are compulsory. Their lack of implementation is a criminal act. With this the Macedonian people authorised the Executive Government to terminate the accession agreements for entry into EU and NATO. In this way the Macedonian people blocked the possibility of blackmail by the EU, threats and false promises as part of the genocidal demands. Europe and its domestic henchmen found themselves stuck. The Macedonian people through its democratic choice stopped the genocidal project. The EU reacted in an express way by sending their High Representative, who here in Macedonia without shame or sense of accountability recommended to us 'To solve the problem in a Balkan Way'. This means the problem can be solved by brutal violation of the constitution and laws of the Republic of Macedonia, and against the wishes of the people at the Referendum.

For our bad luck in the ranks of the Macedonian politicians there are henchmen in the service of EU. Instead of implementing the demands voted for at the referendum and to terminate the accession process with the EU, they implemented the genocidal contract of their EU masters. In that way, the Prespa Agreement signed by an unauthorised person,

contrary to the Constitution of the Republic of Macedonia, with the suspension of the powers of the Macedonian President of the State, it was amended with Constitutional changes. Contrary to the decision at the Referendum, they deleted the glorious, natural, holy, biblical and inherited name Macedonia. This was followed by threats and imprisonment of MPs who were needed for the Constitutional changes. After this shameful act, the EU accession process continued even though the people at the Referendum demanded its cancellation.

But this is not the full account. In order to remove the basic arguments against the bilateralisation of the accession process, the EU built into the genocidal demands of the neighbours into the Framework Agreement, which was unilaterally adopted by all 27 members of the EU. With this action the EU cancelled just in our case their own Copenhagen Criteria for entry and introduced additional genocidal demands in the Framework Agreement. With this action and in writing confirmed that the genocide of Macedonians is European project, and that our neighbours are only executioners tasked with the dirties affairs. However, the worst part of the Agreement Framework they built in a note that they don't recognise the Macedonian language. In this way, the EU for the second time (after the Lisbon declaration) advised us that we can't enter the EU as Macedonian's with a Macedonian language.

The Moral Court hopes that this nazi fascist message will reach Macedonian politicians to implement the wishes of the Macedonia people from the Referendum in 2018 and to terminate the accession talks that inevitably lead to genocide in the form of identity self destruction.

In view of the above facts presented, the Moral Court – Macedonian Truth declared the EU as guilty based on the evidence and articulated the Most Strict Moral Judgement.

This decision will be made public and sent to the Archives of Macedonia.
